## *Parental Agreement of Support*

Harvester Christian Academy exists for the purpose of training young men and women who will reclaim our culture for Christ. This is accomplished in the school environment by training the mind to lead and the heart to serve. In keeping with this purpose, Harvester Christian Academy freely admits children from Christian families where at least one of the parents can give a credible profession of saving faith in Jesus Christ and is an active member in good standing of a Biblically evangelical church.

By signing this agreement you, as parents, are affirming your agreement with the purposes, mission and goals of Harvester Christian Academy.

1. As a Christian family, we commit to regularly attend and take our children to a church in which the gospel of Jesus Christ is clearly proclaimed. Desiring my child's total education program to be effective, we agree that we will maintain for our children an environment away from school which is compatible with the school, especially in the area of moral standards.
2. We agree to abide by all rules and regulations of Harvester Christian Academy and will support those rules and regulations with our children, other Harvester families, and those to whom we speak about the school. Should any problem arise with the school, we agree to follow Biblical principles and, avoiding gossip, speak directly and exclusively to those involved in the problem, prayerfully seeking reconciliation.
3. We delegate authority for the education of our children to the teachers and staff at Harvester Christian Academy. We understand that Christian education may require the correction of our children in both behavior and attitude in an effort to foster Christ like behavior and agree to support Harvester Christian Academy in the discipline of our children.
4. We will pay our tuition and other school-related bills in a timely fashion, recognizing that as parents we are ultimately financially responsible.
5. We understand that providing false, misleading, or incomplete information on the admissions application or any document submitted to Harvester Christian Academy is sufficient grounds for dismissal from the Academy.
6. If for any reason my child does not meet the academic requirements or cooperate with the disciplinary standards in accordance with the procedures as contained in and not limited to the Parent/Student Handbook, we will cooperate with the administration as it handles these situations. We will avoid discussion with those not involved, in an effort to foster a spirit of cooperation and unity. Harvester Christian Academy reserves the right to dismiss, suspend, or otherwise discipline any student who does not adhere to the school standards.
7. Should we at any time violate this agreement, we understand that such violation is sufficient cause for our children to be suspended from Harvester Christian Academy. We further understand that continued failure to comply with this agreement will require us to withdraw our children from the Academy.

We understand by signing below, we agree to comply with the aforementioned for as long as our children are enrolled in Harvester Christian Academy and that this agreement will remain in effect and on file during this time.
